#### 4. ANM for Mobile Health Team, RBSK Koraput under NHM

Selection will be made strictly on the basis of merit.

<u>Eligibility Criteria:</u> In order to be eligible for direct recruitment to the post of ANM, a candidate shall have to satisfy the following conditions, namely-

Nationality- S/he must be a citizen of India.

Age limit- S/he must have attained the age of 21 years and must not be above the age of 32 years as on 01-01-2019 except ASHAs those who have completed 1 year in the health system in the State and below the age of 45 years. She shall be allowed to take part in the recruitment process if having the minimum qualification as required for HW (F). However, age relaxation & reservation policy of State Govt. is to be followed in Toto, for candidates fulfilling criteria prescribed in the said policy (except for ASHA).

#### **Knowledge in Odia-** The candidates must:

- a) Be able to read, write and speak Odia;
- b) Have passed middle school examination with Odia as language subject; or
- c) Have passed matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
- d) Have passed in Odia as language subject in the final examination of class VII from a school or educational institution recognized by the Government of Odisha or the Central Government; or
- e) Have passed a test in Odia in Middle English School standard conducted by School & Mass Education Department.

Marital Status- If married, the candidate must not have more than one spouse living:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person or there are other specific grounds for doing so, exempt any person from the operation of these rules.

<u>Minimum Educational Qualification-</u> The candidates must have passed the HSC examination & shall have completed ANM course from institutions recognized by Govt. and approved by INC and must have registered in the Odisha nursing council.

<u>Physical Fitness</u>- The candidate must be good mental and physical health and free from any physical defects likely make her/his incapable of discharging her/his normal duties in the service. A candidate, who after such medical examination as the Government may prescribe is not found to satisfy the requirements shall not be appointed to the service.

**Registration-** The candidates must have registered her/his name in the Odisha Nursing Council in the state and have possessed valid registration certificates as on the date of advertisement.

#### Competency Based Skill Test (CBST)

- Sortlisted candidates 1:3 would be called in batches for competency based skill tests on 11 skills and related knowledge as per Objective structured Clinical Examination (OSCE) model.
- Candidates securing <70% in the CBST will not be eligible for selection.
- A final merit list will be drawn after the screening through CBST.
