(i) 10<sup>th</sup> class, (ii) essential qualifications and experience(s) (iii) valid caste certificate if applied under SC/ST/OBC/OH category issued by the appropriate/competent authority (iv) No Objection Certificate (if in regular employment in any Govt./Semi Govt./Government Enterprises/Government funded autonomous Institutions) along with a set of self attested photocopy of the said document(s)/certificate(s).
- The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.
