**Note:**

1. Candidates desiring to appear for walk-in-interview should report at Administration Building for registration between **09.00 A.M. and 10.00 A.M.**
2. Interested and eligible candidates are invited with all original certificate and a copy of CV (5 sets). Superannuated teachers may also be considered for engagement as Guest Faculty subject to a maximum age limit of 70 years.

**ELIGIBILITY:**

**1. For Guest Faculty:**

**Eligibility:**

A Master degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign University. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the University Grants Commission (Minimum standards and Procedure for Award of M.Phil/Ph.D. degree) Regulations, 2009 of 2016 and their amendments from time to time as the case may be exempted from NET. Further, the qualification for guest faculty shall be at par with the minimum qualification for Assistant Professors of Universities in UGC Regulations, 2018.

**2. For Medical Officer (on temporary engagement):**

**Essential:** Recognized Medical Degree (MBBS) of any University and Registered with the Indian Medical Council and completion of rotating internship.

**Desirable:**

- a) Post Graduate Degree in General Medicine or equivalent recognized by Medical Council of India.
- b) MBBS with two years of experience.

**Age:** Not exceeding 40 years.

**3. For Physical Instructor (Male and Female) (on temporary engagement):**

**Essential:**

- a) A Master's Degree in Physical Education or Master's Degree in Sports Science with at least 55% Marks (or an equivalent grade in a point scale wherever grading system is followed) with a consistently good academic record.
- b) Record of having represented the University/College at the Inter-University /Inter-Collegiate competitions or the State and /or National championships.
- c) Qualifying in the national level test conducted for the purpose by the UGC or any other agency approved by the UGC.
- d) Passed the physical fitness test conducted in accordance with these regulations
- e) However candidates, who are or have been awarded Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations 2009, shall be exempted from the requirements of the minimum eligibility conditions of NET.

**Norms for the Physical Fitness Test:**

- 1. All candidates who are required to undertake the physical fitness test shall be required to produce a medical certificate certifying that he/she is medically fit before undertaking such tests.
- 2. On production of such certificate mentioned in sub-clause (1) above the candidate would be required to undertake the physical fitness test in accordance with the following norms :

**Desirable:** At least two years of coaching experience from any recognized institute.

**Age:** Not exceeding 55 years.

## **OTHER TERMS AND CONDITIONS:**

### **For Guest Faculty:**

1. Selected candidates shall be paid an Honorarium of Rs 1500/- per lecture subject to a maximum of Rs. 50,000 /- per month.
2. The selected candidates shall be engaged on purely temporary basis for a period of one semester / six months. The services of Guest faculty will be terminated without notice if found unsatisfactory. Under any circumstances, candidate cannot claim any right for permanent position.
3. The number of vacancies indicated in this notification is tentative. The University reserves the right to fill any consequential vacancies, and / or to increase/decrease the number of vacancies and make engagements accordingly.
4. If more number of candidates turn up on the date of walk-in interview, candidates will be advised to appear for interview on another date which will be notified at the venue.
5. No TA/DA will be paid for attending the walk-in interview.
6. Incomplete applications will be rejected.
7. Canvassing in any format or bringing of any influence, political or otherwise, will be treated as disqualification on part of the candidate.
8. Before turning up for interview, please visit the University website for updates.
9. The guest faculty shall not be given the benefit of allowances, pension, gratuity and leave etc. as admissible to the regular teachers.

### **For Medical Officer and Physical Instructor:**

- a. Medical Officer – Rs.55,000/- per month
- b. Physical Instructor – Rs. 35,000/- per month

- 1) The selected candidates will be engaged on purely temporary basis for a period of one semester/six months, which may be extended for one more semester/six months, based on the performance/ requirement or terminated earlier with one month notice on either side, without assigning any reason. Under any circumstances, candidate cannot claim any right for permanent position.
- 2) Candidates may note that these contract positions are basically to meet the immediate academic/administrative requirement of the University and at no point, selection in this walk-in-interview will not make them eligible for regular interviews to be conducted in future.
- 3) Reservation will be made applicable as per UGC/GOI guidelines / norms.
- 4) The number of vacancies indicated in this Notification is tentative. The University reserves the right to fill any consequential vacancies, and /or to increase/decrease the number of vacancies and make engagements accordingly.
