

#### **AGE**:

Should have completed 18 years of age as on 01.07.2019. Upper age limit – Should not have completed 57 years as on 01.07.2019.

## **HIRING CHARGES:**

Hiring basis @ Rs 1000/- per day (6 hours) for 6 days per week.

#### **SELECTION PROCEDURE:**

The Selection of candidates for the engagement of Consultant (AUSH) will be according to weightage of marks obtained by them (in SSLC, HSC, Diploma/Degree) as per the modalities framed by the Government.
