Guidelines for filling of online application

- The Online application has two parts
- ➤ One time Registration
- > Filling up of Detailed Application form

Documents to be uploaded

- a) Scanned colour passport size photograph (taken within 6 months from the date of publication of this notification) in JPEG format. (Maximum size 30 KB. Image dimension of the photograph should be in 150 (width) x 200 (height) pixels). The photograph should be without cap and spectacles; and both ears should be visible. **Application with blurred photograph will be rejected**.
- b) Scanned signature in JPEG format (maximum size 30 KB. Image dimension of the signature should be in 150 (width) x 100 (height) pixels). **Applications with illegible signature will be rejected**
- c) Scanned copy of prescribed Photo Identity proof bearing the Date of Birth (Aadhar Card, Electoral ID Card, Passport, Driving License) in PDF format (Maximum size 1 MB).
- d) Candidates seeking reservation benefits under SC/ST/Non Creamy layer OBC must ensure that they are entitled to such reservation as per eligibility prescribed in the Notice. They should also be in possession of valid certificates in the prescribed format to support their claim. The Scanned document must be in PDF format (maximum size 1 MB.)
- e) Candidates must upload scanned copy of Ph.D. certificate, Post-Graduation certificate, and final year consolidated Post Graduation Mark List (PDF format maximum size 1 MB each for each document).
