(Note:- Out of 899 posts 36 posts are reserved for differently abled persons distributed as follows:- 18 posts for Partially blind & 18 posts for one leg affected persons. Also * posts will be shown in that category in which the candidate belongs.)

(The Honorable Supreme court in Civil Appeal No.3132/2020 has given interim order regarding non-implementation of SEBC reservation in Government Jobs. In pursuance of this interim order the General Administration Department in its letter dated 25.11.2020, informed that the Cabinet meeting held on 05.11.2020 decided to fill 50 % of vacant post of Home Department, Public Health Dept and Medical Education and Drugs Dept. The said recruitment process will be processed accordance with the General Administrative Department.)

(The reservation specified for the D.T.(A), N.T.(B), N.T.(C) & N.T.(D) shall be inter-transferable. If suitable candidates for the posts reserved for D.T.(A), N.T.(B), N.T.(C) & N.T.(D) are not available, the posts shall be filled by suitable candidates from any of the other categories amongst D.T.(A), N.T.(B), N.T.(C) & N.T.(D) as per prevailing Government orders / Act).

- The Reservation for backward class, Sportsperson and Physically challenged person will be as per prevailing order issued by the Government from time to time.
- The number of posts and reservation likely to be changed.

4.1) Out of 899 posts the candidates having Post Graduate Diploma or Degree in following specialist as notified by the Government Resolution, Public Health Department, No SSP-12015/CR 649/15/Seva-3 dated 01.07.2015 will be given preference :-

5. Reservation for Physically challenged persons :-

As per Govt. Notification, Public Health Department, No.Apang.2004/55/Aa-2, dated 27.02.2009 Physically Challenged candidates with low vision and Locomotor Disability (Only one leg affected) are only eligible for this posts and candidates should submit certificate of competent authority mentioning clearly type of disability will only be considered for the post.

The reservation for Physically Challenged persons is as per Government Resolution, General Administrative Dept. No.Divyang-2018/C.R.144/16A, dated 29.05.2019.

6. PAY:

As per seventh pay commission S-20, Rs.56100-177500 and other admissible allowances as per prevalent rules

- As per Government Resolution, Public Health Department, No.MMO.2011/CR No.776/ Seva-3, dated 14th December, 2011 the post graduate diploma holders are entitled for three additional increments and the post graduate Degree holders entitled for six additional increments. Hence the salary of the Medical Officers(Specialists) will be higher than that of Medical Officers(MBBS). However, Post Graduates Degree/Diploma Holder Candidates will be posted according to their educational qualification and as per staffing pattern of the health institution and after such posting they will entitled for additional increment.

7. AGE:

7.1 As per existing rules as on **1st April, 2021, not more than 38 years**. Relaxable as per rules in case of backward class candidates.

8. QUALIFICATION: Candidates must possess.

8.1 FOR MEDICAL OFFICER (MBBS post): The MBBS Degree of a statutory University or any other equivalent qualification as specified in the First or Second Schedule appended to the Indian Medical Council Act, 1956 (102 of 1956);

8.2 FOR MEDICAL OFFICER (specialist posts): The Post Graduate Degree/Diploma in Statutory University in faculty of above mentioned para (4.1) or other equivalent qualification as specified the First or Second Schedule appended to the Indian Medical Council Act, 1956 (102 of 1956);

8.3 The candidates should have completed their internship on or before 31st March, 2021.

8.4 Candidates possessing qualification other than that mentioned in 8.1 & 8.2 above should not apply for this post.

8.5 The last date to apply is 20th April 2021.

- Note:**
- 1) The Medical Officer already working as Medical Officer Group-A (Seventh Pay, S-20, 56100-177500) in Public Health Department are not eligible to apply and such applications stand cancelled & rejected.
 - 2) The Health institutes in Tribal area are declared by, Government Resolution, Public Health Department, No.Ma.Vaii.A-2019/Pr.Kr.165/Seva-3 dated 19.03.2019 experience of working in these areas as bonded / Contract basis as Medical Officer will be considered for weightage of Marks.
 - 3) The candidates should enclose experience certificate as per attached format issued by the competent authority. The competent authority for issuing the experience certificate is Head of the Institute / Office.
 - 4) Service will be counted on 6 monthly periods. No weightage will be given for the service rendered less than 6 months.
 - 5) The cut-off date for the purpose of counting of weightage of marks will be **31st March, 2021**.
 - 6) For evaluation of marks as per the prescribed criteria for selection process the candidates must send self attested copies of mark sheets and certificates along with the application form. Otherwise the application form of the candidate will be rejected.
 - 7) All application forms will be scrutinized by the Director, Directorate of Health Services, Arogya Bhavan Mumbai to prepare the merit list of eligible candidates as prescribed procedure prepared and to be displayed on the website.
 - 8) The eligible candidates will be called for the counseling and should personally remain present for counseling along with original required documents. Representative not allowed.
 - 9) As per the merit list and preferences of the eligible candidates, Government will issue appointment and posting orders on the same day of counseling.

- 10) The selected candidates are required to join at the place of posting within prescribed time limit and will be registered in SEVARTH.
- 11) The selected candidates failing to join at the post of appointment within prescribed time limit will lose their right to appointment and the order will get cancelled on the specified date automatically.
- 12) It is mandatory for newly appointed Medical Officers to stay at Headquarters. Medical Officer's salary is linked with their Bio metric attendance.

10. GENERAL :

- 10.1** Selected candidates will be on probation for a period of two years.
- 10.2** There are prospects of promotion to the post of Maharashtra Medical & Health Services Gr-A (S-23, 56100-177500) provided candidate fulfills the prescribed criteria.
- 10.3** Selected candidates will be debarred from doing any private practice, but will be paid non practice allowance in lieu of private practice according to the rules.
- 10.4** Selected candidates will be required to sign bound to serve Government for a period of five years or in default to pay a penalty amount as may be prescribed by the Government time to time.
- 10.5** Selected candidates will have to get themselves registered with the Maharashtra Medical Council Act, 1965 (Mah.XLVI of 1965), or his/her name should be enrolled in the Indian Medical Register maintained as per the Indian Medical Council Act, 1956 (102 of 1956) before joining duty.

11. NOTE :

- 11.1** Candidates are required to furnish a self-declaration on Rs.100 Stamp paper in respect of correctness and authenticity of the information mentioned in the Application Form. Information if found incorrect then concerned candidate is liable for prosecution as per prevailing rules.

- 11.3** The application Form should be accompanied by the self-declaration, failing which it will be treated as incomplete and will be rejected.
