NOTIFICATION FOR INTERNSHIP FOR THE ACADEMIC YEAR (2021-2022)

Chennai Metro Rail Limited is a Joint Venture of Govt. of India and Govt. of Tamil Nadu and is presently entrusted to execute Metro Rail Project in Chennai City.

2. Who Can Apply:

- (i) Engineering Graduates from colleges recognized by AICTE or Premier Engineering Institutes or Any other Govt. recognized Institute/University, who are presently pursuing 3rd year (6th semester) and above are eligible to apply for internship in Engineering discipline.
- (ii) Students pursuing Chartered Accountancy (CA) and passed all groups of intermediate examination from Institute of Chartered Accountant of India are eligible to apply for internship in CA.
- (iii) The candidates should attach bonafide certificate issued by the concerned Institute to pursue internship. In case of non submission of bonafide certificate, candidate will not be eligible for further selection process.

3. The indicative number of interns required for the Academic Year (2021-2022) in each discipline are as follows:-

* Note: Student who are pursuing M Tech in Environmental Engineering are also eligible to apply for Environment discipline.

4. The candidates selected for internship will be paid stipend of Rs.10,000/- per month.

5. Selection

Applications received online shall be examined by CMRL as per the eligibility criteria notified. Only shortlisted candidates shall be called for test/interview. In order to regulate the number of candidates to be called for test/interview, if so required, the Management reserves the right to raise the minimum eligibility standards/criteria for selection of suitable candidates depending upon the response.

6. The selected candidates will undergo internship in CMRL for a period of 3 months and extendable upto 6 months. The internship certificate will be awarded to interns upon satisfactory completion of their internship and on submission of project report. In the event of discontinuation during the middle of the internship period, no certificate will be issued to the candidate under any circumstances. The selection will be based on the marks secured in the qualifying interview.

General Conditions: -

- Management reserves the right to cancel this notification at any stage without assigning any reason whatsoever.
- In case of any dis-obedience /misbehavior /misconduct, he/she will be immediately sent back to the concerned College/Institute /University.
- During internship, intern shall carry out the assignment entrusted to him/her, confidentiality must be maintained for the same. Interns should not share confidential information about CMRL project works to third party (ies).
- Acceptance or Rejection of application of the candidates will be at the sole discretion of the management. Incomplete applications without Bonafide certificate from Institute will be summarily rejected.
- A recent photograph and signature of the candidate are to be uploaded.
- Verification of credentials such as age, qualification etc. will be done at the time of selection.
- The numbers interns required for the academic year 2021-2022 is only indicative and the same is subject to increase or decrease as per CMRL requirement.
