The written examination shall consist of only one paper.

The pattern of examination shall be only objective/ MCQs (Multiple Choice Questions). The candidates are required to answer the objective type/MCQs in the OMR Sheets and are required to follow the guidelines provided in the OMR Sheet while answering the questions.



APPENDIX II

SCHEME & SYLLABUS OF EXAMINATION FOR THE PURPOSE OF FILLING UP THE POST OF FOREST GUARD UNDER FOREST & ENVIRONMENT DEPARTMENT.

1. All candidates who have qualified in the Written Examination need to appear in the Physical Endurance Test. Physical Endurance Test carries **no marks**, but is only of qualifying nature.
2. The candidates selected in the Written Examination shall be arranged in the order of merit and depending on qualifying in the Physical Endurance Test the overall merit shall be drawn.
3. The candidates should qualify the following physical endurance standards:
